STATE OF OKLAHOMA, COUNTY OF BRYAN:

I, Craig Ladd, the undersigned District Attorney, appointed special prosecutor by the Attorney General, in the name and by the authority of the State of Oklahoma, give information that in said County of Bryan and in the State of Oklahoma, BILLY JOE JONES did then and there unlawfully, willfully, knowingly and wrongfully commit the crime(s) of:

COUNT 1: EMBEZZLEMENT ~ a FELONY, on or between the 1st day of July, 2020 and the 28th day of February, 2022, by fraudulently appropriating the sum of \$37,105.00, via personal ATM withdrawals, from the Fraternal Order of Police, an agency which defendant was entrusted with said funds as a financial officer to pay dues and other various duties on behalf of the membership.

This crime is punishable by imprisonment in the State Penitentiary for up to 8 years and a fine not to exceed \$10,000 and restitution.

COUNT 2: EMBEZZLEMENT ~ a FELONY, on or between the 15th day of March, 2018 and the 23rd day of September, 2021, by fraudulently appropriating the sum of \$67,237.25, from monies seized during arrests for drug offenses while defendant was a narcotics officer with the Durant Police Department, and entrusted to transfer seized monies from the custody of the Durant Police Department to the Bryan County Treasurer's Office.

This crime is punishable by imprisonment in the State Penitentiary for up to 8 years and a fine not to exceed \$10,000 and restitution.
