FINAL ORDER OF REVOCATION

The Council on Law Enforcement Education and Training (CLEET hereinafter), pursuant to 70 O.S. § 3311 and OAC Title 390 Chapter 2, does hereby enter this Final Order of Revocation in the above cause:

FINDINGS OF FACT AND CONCLUSIONS OF LAW

1. That Respondent is a certified Reserve Peace Officer in the State of Oklahoma.
2. That on or about June 19, 2019, Respondent was indicted on one (1) count of Drug Conspiracy in violation of 21 USC §841(a)(1) by a Federal Grand Jury in the United States District Court for the Western District of Oklahoma case CR-19 174 and one (1) count of Possession of Marijuana with Intent to Distribute in violation of 21 USC §841(a)(1) by a Federal Grand Jury in the United States District Court for the Western District of Oklahoma case CR-19 174.
3. That on or about June 3, 2020, Respondent plead guilty to one (1) count of Possession of Marijuana with Intent to Distribute in violation of 21 USC §841(a)(1) in the United States District Court for the Western District of Oklahoma case CR-19 174 and was sentenced to one year and one day in the custody of the Federal Bureau of Prisons.
4. That pursuant to 70 OS 3311, "The Council shall revoke the certification of any person upon determining that such person has been convicted of a felony or a crime involving moral turpitude or a domestic violence offense or has entered a plea of guilty, or nolo contendere or an "Alford" plea or any plea other than a not guilty plea for a felony offense, a crime of moral turpitude or a crime of domestic violence or is the respondent in a final Victims Protective Order. . ."
5. That Notice of Intent to Revoke was mailed via certified, return-receipt requested, tracking number 7020 0640 0001 4676 0061, on January 18, 2023, to Respondent at his or her address on file with CLEET.
6. That on or about February 13, 2023, CLEET received the returned letter corresponding with certified mail tracking number 7020 0640 0001 4676 0061.
7. That no request for hearing has been received pursuant to OAC Title 390 Chapter 2.

8. That pursuant to 70 O.S. § 3311(P), individuals regulated by CLEET are obligated to maintain a current mailing address on file with CLEET and notices properly delivered to such address constitute good service.

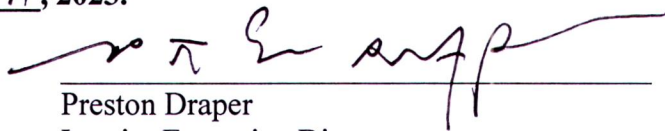
DISPOSITION

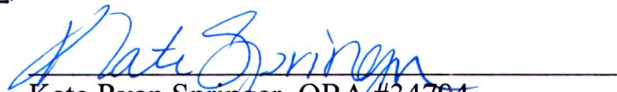
