

On May 25, 2023 I went to court in person with Mr. Milton C Rankins and I thought that we were there to resolve issues about schooling with my kids so that Mr. Don guard three can help me basically print out some homeschool instructions so that I can get me and my kids Back on track and I thought that was what was happening until everybody in the court I said that they were done with the issue and that they help me as best as they could, except for Patrick, K and his legal department/that same day, Patrick K, outlaw prejudice, Lee till the court that he was not done with me, and that same day he put something on my door, telling me to bring them my kids. I felt like this was very biased and prejudice activity due to, I had just resolve issues with magistrate Milton C rankings, I feel like I am being lashed out and retaliated against and so are my children in CPS custody now are being lashed out and bully Cps in Patrick Kay with their legal department has been attacking me because of my complaints about child abuse and child neglect the 14th amendment basically rights Of Cps remind Cps that the US supreme courts has repeatedly held that parents have a fundamental right to make decisions as to the companionship, care, custody and management of their children, which race is to protect liberty interest under the due process clause of the 14th amendment and I am Michelle wright didn't know wrongdoing for them to lower me to the juvenile justice center just to target and interrogate me and to create false charges to throw me in jail and to kidnap my kids. I am hoping that my children return home safe ASAP do too. I am not a law breaker. I live in a common law status. I have been retaliated against and iam scared for my life and I cant purse my happiness with them hunting me and trying to abuse there authority

At my first hearing with Miss McDougall, it seems like she was being prejudiced towards me, or maybe even bias I am scared to go onto any further hearings with any one that is affiliated with her since that they don't see the aim injustice that has happened to me, including me being thrown in jail from the juvenile justice center just so that they can see COERCION me into signing contracts about giving me my children back when it was promised during a hearing with Miss Schaeffer now I got out and they want me to deal with an old Cps Worker that was already court order to give me my children back and now she's back on a new case I am asking for fair judgment. I am afraid that I will not get it if it comes from Judge Linda Tucci Teodosio. They arrested me on the date May 26 for no reason and also conspired to charge me with false charges and they have the sheriffs office of Akron and the Akron public police department with the job and family services trying to force me to sign a contract that has not to do with any thing with lawful things just demanding that I do certain things that are not in my religion or my culture and they have my kids and they keep telling me that they discipline my kids in when I see my kids, they are in distress and 911 they slander my name and say things that are not true and they all gang in conspire against the trafficking of me and my kids only because I complain about child neglect and child abuse. I have been being attacked for three years now, and I don't feel that the judge, or the magistrate is going to treat me fair and has not been treating me or my children fair. and they had the sheriffs take me to jail twice on the same charges, and I also have audio of them plotting against me with no legal papers and actually coming to my house with no legal papers. They were acting like tyrants that does not acknowledge the law for what it is they were bullying harassing stocking and etc. me down to the point where they can't come to my house anytime they want to. They called the police on me anytime they want to they right here say just to steal my children just to drag me in and out of the quart room, knowing that I haven't committed any crime. And also being retaliated against since I am choosing home school for my disabled sons and my son has a medical problem on his legs that's why I'm choosing to keep him home and because he was kidnapped by Leah Swelle in 2021 and now they are back again maliciously attacking me for no reason. An unlawful arrest an unlawful search, unnecessary, force, rude, conduct, abusive, threatening, poor attitude, discrimination, excessive police service, lying under oath, failure to take action county property was missing, bribes and abuse of authority, and had no lawful reason to file a complaint, or to grant one after it was resolved on 26 May 2023 with Milton c Rankins. And since Cps social workers are government agents, they cannot act in a way that violate your constitutional right to due process for your protection from any unreasonable, searches and seizures. And the fourth 18th amendment rights of Cps, the US supreme courts has repeatedly held that parents have a fundamental right to make decisions as to the companionship, care, custody and management of their children which rights is a protected liberty interest under the Ddue process clause of the 14th amendment. I'll contest to the petition and did not get a chance to do that because they intimidated me harshly. if I am influenced to sign a contract, this is an act of COERCION this action is an act of violence and threats to my defense. This UNSERUPULOUS group has conspire against me to take my children on numerous occasions creating narratives that don't exist in writing fake documents to take my children for no reason undue influence meaning the use of false imprisonment threats for psychological pressure or COERCIONS, to influence someone to act in a way that is not in their best interest, or to act in a manner that they do not wish to add consideration is what is referred to bargaining in exchanging taking place regarding goods and services? It is vital, and without it, a contract does not exist when one party benefits, but the other only receive what was initially promised, this is duress, pass consideration will typically not be recognized as valid consideration for a present contract. Therefore, failure to

have proper consideration will result in a failure to have proper results in a unforeseeable invalid contract that is, of course, unless an exception exist such as promissory ESTOPPEL and that is exactly what happened that day, except for I will not sign anything because they are all working against me

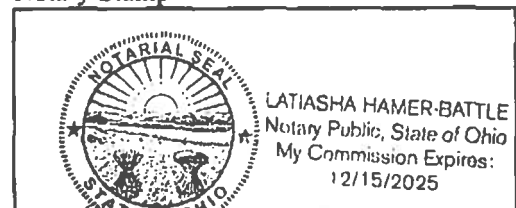

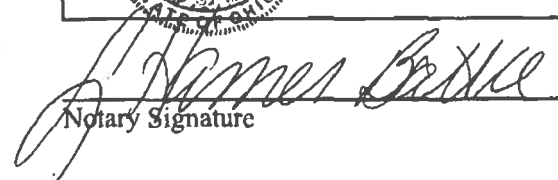

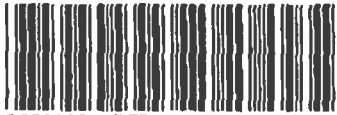

I want to appeal this, because there is no factual basis on threatening to take my children or disciplining me because I said my children are being abused in school. I feel like you should have had more help, then dishing out, discipline and threatening take my children because i've reported child neglect and child abuse. Ms. Wright was arrested and charged with O.R.C. 2919.23 Interference with Custody, a misdemeanor of the 1st degree and O.R.C. 2919.22 Endangering Children a misdemeanor of the 1st degree through Akron Municipal Court. She was transported to and booked into the Summit County Jail.

NARRATIVE

Summit County Children's Services requested the assistance of our agency for the removal of children from their mother Michelle Wright and their home at 575 Fernwood Drive Akron, Ohio 44320. The children are Zion Wright age 12; Jacob Bazin age 7; Miyonni Bazin age 5.

Summit County Children's Services Case Worker Leah Sewell was present at the location. She provided the emergency custody and removal order issued from the Summit County Juvenile Court.

We attempted to make contact with Ms. Wright at her residence. She was not home, we spoke with neighbors who stated if Ms. Wright's car is not in the driveway she is not home. They stated she had not been home all day.

Case worker Sewell was advised and stated their agency would attempt to make contact with Ms. Wright on 05/26/2023. Case Worker Sewell requested a copy of the court order be left on the front door of the residence for Ms. Wright.

On 5/26/2023, we attempted to contact Ms. Wright at her home and to gain custody of the children. Ms. Wright and the children were not home, neighbors stated they had not seen her all day.

Ms. Wright was scheduled for an emergency custody hearing at the Summit County Juvenile Courthouse at 1500 hours on 5/26/2023. Ms. Wright appeared in court, however she did not have any of her children with her.

Ms. Wright was present with her lawyer as well as a Guardian Ad litem for the children. Summit County Children Services Case Worker Ms. Sewell was also present in court via zoom.

Ms. Wright was asked numerous times by Summit County Juvenile Court Magistrate Mendlik, as well as Assistant Prosecutor Tomko about the location of her children and whom they were with. Ms. Wright provided the court with a name, but it could not be confirmed that the individual mentioned actually had the children. She refused to provide the court with location of her children. Ms. Wright had multiple family members and friends in the courtroom with her, none of which admitted to knowing the location of the children.

The court maintained the emergency custody order granting custody of the children to Summit County Children's Services.

Ms. Wright stated she would have her children brought to the courthouse so they could go with Summit County Children's Services. However, after approximately an hour and a half, the children had not been brought to the court. Ms. Wright began to complain of not feeling well, she stated she vomited in the restroom and was having chest pains. Akron Fire/EMS was requested to evaluate Ms. Wright. Akron Fire EMS Med 7 responded and evaluated Ms. Wright, through their policy and procedure Ms. Wright's condition was discussed with Dr. Farson from Cleveland Clinic Akron

On 05/25/2023 Summit County Children's Services obtained an order issued by the Summit County Juvenile Court, granting the agency emergency temporary custody of the children. The Summit County Sheriff's Office assisted the agency in attempting to locate and take the children into custody. The attempt was unsuccessful as Ms. Wright was not at her residence and could not be located.

05/26/2023 The Summit County Sheriff's Office again assisted Summit County Children's Services in locating Ms. Wright and her children, however this attempt was also unsuccessful. Ms. Wright was not at her residence and could not be located.

On 5/26/2023, Ms. Wright appeared at the Summit County Juvenile Court for her scheduled emergency custody hearing. She did not appear with any of the children. She was asked numerous times in court where her children were, she continuously refused to provide the location of the children.

Ms. Wright later agreed to have the children brought to the courthouse so Summit County Children's Services could take custody of them, however they never appeared and she provided several different excuses as to why the children could not be brought to the court. She still refused to provide their location.

After approximately an hour and a half of trying to get the children to the court, Ms. Wright told me she did not know if the children were on their way. She again refused to provide any information about their location.

The three children were entered into LEADS as missing children.

She was arrested and transported to and booked into the Summit County Jail.

SCCS still does not have physical custody of the children.

WHEREFORE, the undersigned prays that this Court issue an order finding Michelle Wright in contempt of this Court and granting any further relief to which the Court may deem proper. SCCS is asking for an expedited hearing to be scheduled.
