NARRATIVE

On September 13, 2022, Officer J. Mogavero was dispatched to 2235 Burroughs Ave SE on a Burglar in a residence. Upon arrival they located the victim, who advised that an unknown male entered her home and sexually assaulted her. Officer Morgavero spoke with Sgt. Leduc and advised her on the matter. Lt. A. Smith, Sgt. Leduc, Inv. Bradford, and I relocated to the incident location to try and speak with the victim and have the crime scene processed.

Upon our arrival had been transported to Grady Hospital by ambulance with her son, I Officer Mogavero stated that heard her son screaming in his bedroom. When she went into the room she saw a male holding her son down with his penis out. grabbed a pole and struck the suspect, trying to get him to let go of the child. Officer Mogavero stated that the child's diaper and pants were removed when the suspect was attacking the child. The suspect then attacked pushing her inside her room, removing her clothing. He pushed her to the bed and inserted his penis into her vagina. The suspect was able to take the victim's car keys and flee the location with her vehicle. A lookout of the vehicle was given over the radio. The vehicle was a silver 2015 Hyundai Elantra, Georgia tag, (CUJ6937). Inv. Walters was sent to Grady Hospital to interview A sexual assault kit was completed on and she was advised to have her son taken to Hughes Spalding Children's Hospital to be evaluated as well. A supplemental report will be completed by Inv. Walters.

Officer Mogavero stated that the victim gave us permission to go inside her home to process and look for evidence of the crime. Inside the home Officer Mogavero showed us bedroom and her child's room. She show us the child's pants and diapers that were removed and his mother's bra that was on the child's bed. The pole was on the floor in the child's bedroom. Inside room was a pair of panties on the floor and her bed sheets. The victim also stated that the suspect was wearing a pair of her work gloves. One glove was located in the rear of the house.

said the suspect was an older teenager, possibly age 16 to 17. He was described as wearing a black hoodie with the logo of Backwood on the front of the hoodie. The suspect was described as tall black male with a dark complexion. He had twisted dreads and a tattoo on his right hand. stated that the suspect had a mask covering his face but she could see his eyes. She believes it was a young teen male that walks around in the area. She often encounters the male walking in the street pass her house and he gives her compliments.

old Officer Mogavero that the as the suspect was running out of her house she asked how he got inside the home. The suspect stated the back door. Officer Mogavero stated that the back door was open. The back door didn't have a outside door knob. There was no sign of forced entry. ID Unit Dunn came to the location and processed the scene. He recovered sheets from both beds, pants, anties and bra, the glove, and took pictures of the outside and inside the home.

There is a ring camera next door at 2229 Burroughs Ave SE. A spoke to the family at the home and their grandmother, Ms. Broughton has access. She wasn't at home at the time. I called her and left a message. They provided her number (470-421-1885). A witness from across the street, Mr. Kingsley Reid (470-733-2051) saw the suspect from behind enter the victim's vehicle. The suspect left the location in the car. Mr. Reid stated that came running out of her home and yelled at the suspect as he drove from the location.
