Narrative Report

On the listed date and time, officers were called to 9 Grove Ave Ext for a disturbance. Officers arrived and spoke with two victims in the residence. The victims and witness indicated five people entered his home without permission. One of the suspects, according to the victims, brandished a handgun then pointed at the victim's head. The victims identified the suspects involved and believed they were heading to the Plymouth area.

Assistance was sought from the Huron County Sheriff's Office. Deputies were able to locate two of the suspects and place them into custody. Officers then met with the deputies and secured the firearm along with the two suspects. After a brief discussion from the Richland County Prosecutor's Office, it was decided to charge two of the suspects with Aggravated Burglary. The two were then booked into the Shelby City Jail on a \$100,000 bond. They will appear in Shelby Municipal Court on November 2nd, 2022 at 0900 hours.

I hereby make the following statement of my own free will. No promises, threats or coercion of any kind have been used to elicit this statement from me. I understand that by signing this statement / affidavit I am swearing to the truth of the facts stated therein.

I was sitting at the computer in the living room, back was towards the door. The door was forced in, I had turned around to see Lauren, Nate (her XBF) walking towards the back room. Lauren's sister came into the living room and grabbed flower and sign decorations off the wall. Her mother had stepped 4-5 feet within the door and started speaking to me. She only spoke momentarily until she started raising her voice and shouting. I had looked over to my mom and Sunny, to see Lauren's sister pull a gun, and put it to my mom's head and she said, "I'll shoot ya Bitch". Then her boyfriend had grabbed her and pulled her back from my mom. All while Lauren had came from the back with Nate, she started shouting that she lived here, and I said No, Beece from SPD had contacted Lauren and told her that I wasn't pursuing charges for her assaulting me, if she would get her things and leave.

I told him that I had to draw a line because I'm tired of being disrespected and will not tolerate her putting her hands on me. This was what I stated to Lauren. Lauren said the Cops had known they were coming here, Lauren went for my mom and said "Wanna go for round 2?" Then started towards me which nate had grabbed her and pulled her back. I then looked to Rita and said that Lauren had sold 7000 worth of my guns, phones, and tools, left me sit in jail over her lie, ~~and~~ cheated on me with my friend, and that she was not taking the G6 that can be dealt with in Civil Court. that she had 2200 from Friswain, claiming and sold the car for 750, which I paid \$1000 for the G6 for her. She still owes my uncle \$500 and didn't pay him anything out of her 2200. And she took my tools and traded to her mom and step dad for it to begin with.
